

## Type C Visitor Visa (for private purposes)

For the period of up to **90 calendar days**, single-, double- or multiple-entry:

Apart from a duly completed visa application form, valid passport, one photograph, a letter from insurance company, payment the following visa support documents to be submitted:

- An original invitation issued by a department of citizenship and migration of a regional office of the Ministry of Internal Affairs of Belarus;  
*or*
- Official confirmation on illness or death of a close relative (e.g. physician certified report or death certificate) – for processing a visa to an applicant (his/her close relatives and family members), whose close relative is ill or died in Belarus;  
*or*
- A subpoena (received by facsimile or other means of communication);  
*or*
- An original document confirming ownership of real estate property in Belarus - for processing a visa to the owner of the property ( his/her family members);  
*or*
- Petition made by Belarusian healthcare institution or contract for medical services with Belarusian healthcare institution – for processing a visa to an applicant who intends to receive medical care in Belarus as well as to his escort person;  
*– or*
- — An application by a citizen of Belarus in accordance with a set form [[Doc-file, 84Kb](#)], whose signature is certified by a Belarusian Embassy or Consulate officer authorized to perform notarial acts or a notary public of the Republic of Belarus. Application is valid 90 days from the date of certification.

For the period of up to **30 calendar days**, single- or double-entry:

Apart from a duly completed visa application form, valid passport, one photograph, a letter from insurance company, payment one of the above mentioned visa support documents is required.

*or*

By the prior consent of consul citizens of Finland and other EU member-states, US, Canada, some other countries (please, check with the Consular Section), applying for a visitor visa valid up to 30 calendar days or less may submit their documents ***without providing a letter of invitation***, if the inviting person's first and last names, home address and contact details (phone number) is indicated in the visa application form (paragraphs 20-22). Please, be advised that failure to comply with this requirement (proper completion of visa application form) will result in a rejection of visa request.

Please, kindly note that the consular official may request additional documents, other than those specified in the foregoing, confirming the information contained in the visa application form and/or the letter of invitation. Refusal to provide the requested documents may lead to withholding a permit to enter Belarus.
